# Introduction

Quantitative economic statistical techniques called "econometrics" attempt to model the economy using mathematical relationships. and statistical comprehensive model of the economy might have hundreds of equations and many variables. Econometrics is concerned with providing a basis for reasoning and learning from samples of economic data. To provide a basis for processing and recovering information from samples of economic data applied econometrics is grounded in probability theory and the principles of estimation and statistical inference.

Research work / Dissertation is compulsory in the curriculum of almost all post graduate programmes. However, there is a dearth of well trained, specialist faculty in the subject. It is necessary to develop faculty base in this area. Looking at these requirements Gujarat Technological University, Ahmedabad has planned to organize this FDP on "Introductory Econometrics with Modern Approach".
